Domestic abuse is about control – about how one person uses an intimate relationship to control another person, often their partner or former partner. It can take many forms, and includes physical abuse, financial control, threats, emotional abuse or sexual abuse.

Anyone can experience domestic abuse, regardless of race, age, ethnic or religious group, disability or lifestyle, and it can happen at any stage of a relationship.

Domestic abuse destroys both victims' and children's lives. The effects can range from severe emotional harm to physical injury and it can take a long time to recover.
